Note No. 1 - Clarification on total number of shareholders under 'Promoter and Promoter Group as on 31 December 2021 as per the Register of Members of Kirloskar Industries Limited (KIL / the Company), the total number of shareholders, who are holding shares under the 'Promoter and Promoter Group' are 28 (23 folios of Individuals and 5 folios of Bodies Corporates). Based on intimation received from BSE, the total number of 'Promoter and Promoter Group' are revised to 20 instead of 28 in the Table I and Table II by consolidating different folios on the basis of same PAN. Note No. 2 - As on 31 December 2021 as per the Register of Members, the total number of public shareholders are 19078. The different folios of public shareholders are consolidated on the basis of same PAN. As such, the total number of public shareholders appearing in table I and III are 18680. In view of the aforesaid Note No. 1 and 2, the total number of shareholders of the Company is appearing as 18700 instead of 19106. Note No. 3 - Mr. Atul Chandrakant Kirloskar holds 12,83,562 shares, out of these 12,83,537 shares in the individual capacity and 25 shares as a trustee of C. S. Kirloskar Testamentary Trust. Note No. 4 - Mr. Rahul Chandrakant Kirloskar holds 16,21,688 shares, out of these 16,21,459 shares in the individual capacity and 229 shares as a trustee of C. S. Kirloskar Testamentary Trust. Note No. 5 - Mr. Sanjay Chandrakant Kirloskar holds 2,626 shares, out of these 2,362 shares as a trustee of Kirloskar Brothers Limited Employees Welfare Trust Scheme, 250 shares in the individual capacity and 14 shares as a karta of Sanjay Kirloskar HUF. Note No. 6 - Mr. Vikram Shreekant Kirloskar holds 4,632 shares, out of these 4,380 shares as a trustee of Rooplekha Life Interest Trust and 252 shares in the individual capacity. Note No. 7 - Mrs. Mrunalini Shreekant Kirloskar holds 5,856 shares, out of these 3,731 shares in the individual capacity and 2,125 shares as a karta of Shreekant S. Kirloskar HUF.
