Note No. 1 - Clarification on total number of shareholders under 'Promoter and Promoter Group as on 31 December 2023, as per the Register of Members of Kirloskar Industries Limited (KIL / the Company), the total number of shareholders, who are holding shares under the 'Promoter and Promoter Group' are 24 (19 folios of Individuals and 5 folios of Bodies Corporates). Based on intimation received from BSE, the total number of 'Promoter and Promoter Group' are revised to 19 instead of 24 in the Table I and Table II by consolidating different folios on the basis of same PAN.

Note No. 2 - As on 31 December 2023, as per the Register of Members, the total number of public shareholders are 17647. The different folios of public shareholders are consolidated on the basis of same PAN. As such, the total number of public shareholders appearing in table I and III are 17265.

In view of the aforesaid Note No. 1 and 2, the total number of shareholders of the Company is appearing as 17284 instead of 17671.
